RE: INVITATION FOR REVIEWING AND DEVELOPING OCCUPATIONAL STANDARDS AND PROGRAM DELIVERY STANDARDS TO SUPPORT TVT DEVELOPMENT IN ETHIOPIA

With a large youth population in the country, the federal government of Ethiopia has been working hard to provide education and training of high quality that can promote human resource development for economic growth and social justice. Among all levels of education, Technical and Vocational Training (TVT) is always regarded as the key step to link young people with the demand of the economy while providing them with lifelong skills and employment opportunities.

The Ministry of Labor and Skills (MoLS) has achieved remarkable outcomes in TVT development, including establishing the Ethiopia National Qualifications Framework (ENQF) and increasing the number and quality of TVT institutions, staff, and students that all supported the country to become one of the most rapidly growing countries in Africa. Nonetheless, the country still faces challenges, including slow economic growth, increasing youth unemployment rate, and most employed population staying in the agriculture sector.

Based on past experience and current challenges, The Ethiopian Ten Years Perspective Development Plan (2021 – 2030) makes the development of human capital one of the key enabling sectors for the future prosperity of the country. Hence, the ministry hopes to review, reform, and develop new strategies for TVT sector to achieve this goal.

In the Ethiopian National TVT Strategy, the Ethiopia Occupational Standards (EOS) is the core element and an important factor within the context of the National TVT-Qualification Framework (NTQF). They are national Ethiopian standards, which define the occupational requirements and expected outcomes related to a specific occupation according to the demand of the industry. In the past decade, there are around 400 EOS developed in total, for which we hope to review and refine them to catch the new development in the industry and meet contemporary international standards.

We have learned that TVT in China has benefited from a persistent high-quality standard setting, and China-Africa Vocational Education Alliance (hereafter "the Alliance") has a rich network of a broad number of experts and flagship TVT institutions in China that have been involved in the standard-setting work domestically and internationally, especially in East African context. Therefore, we kindly request your office to support the review of the current EOS and the development of a new EOS.

Also, based on lessons learned in recent years, we understand that it is crucial for TVT institutions to deliver programs that match the requirements of EOS. According to China's experience, we find that the Program Delivery Standards (PDS) formulated according to Occupational standards can largely guide to preparation of qualified curriculums while also providing a standardized document for the ministry to monitor the quality of delivery. Therefore, we kindly request your office to support the development of Program Delivery Standards in TVT of Ethiopia based on the list of EOS.

Specifically, we hope the work can start from key sectors in Regional Flagship TVT Institutes in Ethiopia, which are specifically Textile and Garment, Leather, Mechanical and Tool Making, Automotive, Railway, Energy, Agro Processing, and the national five priority sectors: Agriculture, Manufacturing, Tourism, Mining, and ICT. The proposed list for EOS and PDS to be reviewed and developed is displayed in Annex I. The ministry warmly invites you to refine the proposed list based on the capacity of your office, especially proposing new occupations benefiting the development of Ethiopia. At a later stage, we shall finalize the list upon mutual agreement.

The ministry is looking forward to cooperating with your office on the above numerous projects to enhance the development of TVT in Ethiopia to meet the goal of The Ethiopia Ten Years Perspective Development Plan (2021 – 2030) and support a prosperous Ethiopia.
